### 6. FINANCIAL REPORTS – 2022 BUDGET:

A proposed MVBIA budget for fiscal 2022 has been distributed proposed. General discussion of events followed, and Heather presented results of a recent survey of the BIA membership which showed strong support for the events in general.
